A simple oath: To grow old in America must never mean to grow invisible. Every elder deserves dignity, safety, and support — from health care to housing, from caregiving to community. This is not optional compassion. It is a national oath of care.

Why It Matters

- By 2030, one in five Americans will be over the age of 65.
- Millions of seniors face poverty, isolation, inadequate housing, and health insecurity.
- Elder abuse affects an estimated **1 in 10 older adults** each year, often unreported.

1. **Community Care Hubs:** Local centers combining health, meals, counseling, and social programs for seniors.

3. **Elder Justice Units:** Specialized state and local teams to detect, investigate, and prosecute abuse.

0–100 Days

- Establish a National Task Force on Aging and Caregiving.

- Pass caregiver tax credit legislation.

Years 2–3

- Double caregiver support services nationwide.
- Expand affordable senior housing construction through the Senior Housing Trust.

Years 4–5

- Achieve nationwide coverage of Community Care Hubs.
- Embed elder justice units in every state.

Accountability & Measures

- **Access:** % of seniors with affordable care and housing options.
- **Caregivers:** Number using tax credits, respite care, and workplace protections.
- **Safety:** Reduction in elder abuse cases; increased reporting and prosecution.
- **Connection:** Rates of senior participation in volunteer, education, or community programs.

- Senior housing availability expanded by 1 million units.

In 10 Years

- Aging with dignity becomes a national standard. No elder is invisible, exploited, or abandoned.

The Commitment

The Dignity in Aging Oath is a pledge that no American will outlive their worth. Elders will not be left behind — they will be honored, supported, and protected as vital members of our shared republic.

Historical Reference & Value

Throughout American history, efforts to protect older citizens have marked turning points in the nation's understanding of dignity. The Social Security Act of 1935 established a safety net that lifted millions of seniors out of poverty. In 1965, Medicare and Medicaid revolutionized access to healthcare for older Americans. The Older Americans Act, also passed in 1965, created services like meals on wheels and senior centers, embedding the principle that aging should not mean abandonment. Yet gaps remain: elder poverty persists, caregiver burdens are overwhelming, and abuse often goes undetected. The Dignity in Aging Oath draws from these milestones but elevates them to a permanent civic standard — declaring that care for elders is not charity, but a national duty.
